MARKET UPDATE(a)

North America

- Sales growth above expectations driven by a profitably growing direct channel and strong demand across all channels through March 2, 2020.
- We are comfortable with our supply chain of products for the U.S. business from China. The majority of U.S. products sold in the U.S. are produced in the U.S., limiting our supply chain exposure.

International

International is stable, driven by growth above plan in Europe, offset by underperformance in Asia. The majority of our business in China runs through a 50% joint venture which somewhat mitigates the financial impact from the health issues in China. Five of six plants have reopened to support the Chinese market. We continue to monitor this dynamic situation.

Capital Allocation(b)

- > As previously disclosed, the Company expected to repurchase approximately \$50 million of shares each quarter. Due to market conditions, the Company expects to exceed this quarterly forecast and repurchase approximately \$100 million during the first quarter.





These non-GAAP measures should be considered supplemental in nature and should not be construed as more significant than comparable n defined by GAAP. Because not all companies use identical calculations, these presentations may not be comparable to other similarly titled measures of other companies. Constant Currency Information

In this presentation the Company refers to, and in other communications with investors the Company may refer to, net sales or earnings or other historical financial information on "constant currency basis," which is a non-GAAP financial measure. These references to constant currency basis do not include operational impacts that could result from fluctuatior foreign currency rates. To provide information on a constant currency basis, the applicable financial results are adjusted based on a simple mathematical model that translates curr results in local currency using the comparable prior corresponding period's currency conversion rate. This approach is used for countries where the functional currency is the local currency. This information is provided so that certain financial results can be viewed without the impact of fluctuations in foreign currency rates, thereby facilitating period-to-peric comparisons of business performance.

EBITDA and Adjusted EBITDA

A reconciliation of the Company's GAAP net income to EBITDA and adjusted EBITDA is provided on the subsequent slides. Management believes that the use of EBITDA and adjuste provides investors with useful information with respect to the Company's operating performance and comparisons from period to period.

Adjusted Net Income

A reconciliation of the Company's GAAP net income to adjusted net income and a calculation of adjusted EPS are provided on subsequent slides. Management believes that the use adjusted net income and adjusted EPS also provides investors with useful information with respect to the Company's operating performance and comparisons from period to perio

Leverage

Consolidated indebtedness less netted cash to adjusted EBITDA, which the Company may refer to as leverage, is provided on a previous slide and is calculated by dividing consolida indebtedness less netted cash, as defined by the Company's senior secured credit facility, by adjusted EBITDA. The Company provides this as supplemental information to investors the Company's operating performance and comparisons from period to period, as well as general information about the Company's progress in reducing its leverage.
